Information about countries of the world is collected by and available from the United States Government and from individual states and countries as well.

For instance, California's [Centers for International Trade Development: CITD](http://www.citd.org) ([www.citd.org](http://www.citd.org)) and [TradePort](http://www.tradeport.org) ([www.tradeport.org](http://www.tradeport.org)) help Californians expand trade. TradePort offers country profiles from the World Trade Press .

Major English-speaking countries besides the United States furnish country information, and their Web sites offer U.S. citizens different country perspectives.

For instance, [Austrade](http://www.austrade.gov.au) ([www.austrade.gov.au](http://www.austrade.gov.au)) ,

the [Australian Government Department of Foreign Affairs and Trade's Country, Economy and Regional Information](http://www.dfat.gov.au/geo) (<http://www.dfat.gov.au/geo>),

[Foreign Affairs and International Trade Canada](http://www.international.gc.ca/index.aspx) ([www.international.gc.ca/index.aspx](http://www.international.gc.ca/index.aspx)) , and the

[United Kingdom's DFID: Department for International Development](http://www.dfid.gov.uk) ([www.dfid.gov.uk](http://www.dfid.gov.uk)) and

[Foreign & Commonwealth Office](http://www.fco.gov.uk) ([www.fco.gov.uk](http://www.fco.gov.uk)) all furnish snapshots of countries.

**The U.S. Federal Government produces a few premier country studies resources.**

CIA's [World Leaders](https://www.cia.gov/library/publications/world-leaders-1/index.html) (<https://www.cia.gov/library/publications/world-leaders-1/index.html>) offers an online directory of the Chiefs of State and Cabinet Members of Foreign Governments.

NationMaster (<http://www.nationamaster.com>) even enables individuals to view many of these statistics in maps offering graphic-rich formats.

The general, overall site [U.S. Department of State](http://www.state.gov) (<http://www.state.gov>) offers a wealth of information, including foreign policy news.

Related sites include [Websites of U.S. Embassies, Consulates, and Diplomatic Missions](http://usembassy.state.gov) (<http://usembassy.state.gov>); and [Travel.State.gov](http://Travel.State.gov), which supplies travel information and warnings

Important aspects of doing business abroad include identifying market opportunities and understanding trade rules.

[Export.gov](http://www.export.gov/), the U.S. government's export portal, provides a single access point about export procedures, industries, markets, trade leads, and events.

From its [Market Research Library](http://www.buyusainfo.net/adsearch.cfm?search_type=int&loadnav=no) ([http://www.buyusainfo.net/adsearch.cfm?search\\_type=int&loadnav=no](http://www.buyusainfo.net/adsearch.cfm?search_type=int&loadnav=no)) individuals may search by report type to access the most recent U.S. Commercial Service's *Country Commercial Guides* and other market materials. Prepared by embassies and several other U.S. government agencies, the *Country Commercial Guides* assess country risks for doing business, and therefore provide good overviews of countries' economic and political environments.

Labor is also an important component of conducting business or trade abroad. Information abounds on the topic of labor worldwide, and much of it comes from the Department of Labor, including the Bureau of International Labor Affairs- ILAB (<http://www.dol.gov/ILAB/>)

Almost every U.S. agency produces some form of international information.\

## LIBRARY OF CONGRESS

The Library of Congress is a leader in digitized collections and Web resource directories, in addition to providing library catalogs and bibliographic information

From its [Global Gateway: World Culture & Resources](http://international.loc.gov/intldl/intldlhome.html) (<http://international.loc.gov/intldl/intldlhome.html>), visitors may access both Portals to the World and Research Guides and Databases.

Portals to the World, which is organized by LOC subject experts, facilitates the identification of key Internet resources from countries. Organized alphabetically and then subdivided by topical area, it serves as a good starting point

Currently, the Federal Research Division prepares shorter and regularly updated [Country Profiles](http://lcweb2.loc.gov/frd/cs/) (<http://lcweb2.loc.gov/frd/cs/>) that furnish overviews of countries' economic, political, military, and national security climates. This resource's main menu of hyperlinked country names also lists the months and years the profiles were created. As with its predecessor, country coverage is selective.

Other items available from Research Guides and Databases are the the [Global Legal Information Network \(GLIN\)](http://www.glin.gov/search.action) (<http://www.glin.gov/search.action>) GLIN is a database of country laws, regulations, judicial decisions, and legal documents.

Other LOC Web sites that may supplement country studies are the [Geography & Map Reading Room](http://www.loc.gov/rr/geogmap/) (<http://www.loc.gov/rr/geogmap/>) and [BEOnline+](http://www.loc.gov/rr/business/beonline/subjectlist.php), (<http://www.loc.gov/rr/business/beonline/subjectlist.php>) from the Business Reference Services division.

## FEDERAL RESERVE

The Board of Governors of the Federal Reserve System, the central bank of the United States, controls and monitors monetary policy, money supplies, and banking operations in the United States.

The Federal Reserve has an elaborate library system supporting its many regional banks. Its libraries disseminate a wealth of information pertinent to country studies, especially information relating to macroeconomic variables.

Resources available include [Global Economic Indicators](http://www.ny.frb.org/research/global_economy/globalindicators.html) ([http://www.ny.frb.org/research/global\\_economy/globalindicators.html](http://www.ny.frb.org/research/global_economy/globalindicators.html)) (Federal Reserve Bank of New York); and the Federal Reserve Bank of Cleveland's [Inflation Central: World Inflation](http://www.clevelandfed.org/research/Inflation/World-Inflation/Index.cfm), (<http://www.clevelandfed.org/research/Inflation/World-Inflation/Index.cfm>) featuring interactive charts.

The Federal Reserve Bank of St. Louis's recently rolled out [Liber8](http://liber8.stlouisfed.org/) (<http://liber8.stlouisfed.org/>) which it describes as “an economic information portal for librarians and students.” Liber8 contains the in-house IES (International Economic Statistics) Database, accessible from its home page, and featuring international economic statistics.

## INTERNATIONAL ORGANIZATION RESOURCES AND STATISTICS

UNCTAD: United Nations Conference on Trade and Development, the World Trade Organization (WTO), and the Organisation for Economic Co-operation and Development (OECD), study trade factors and patterns, and economic strength and competitiveness and offer statistics and country and trade profiles.

Among the important free online publications from UNCTAD for studying various types of trade statistics is [Development and Globalization: Facts and Figures](http://globstat.unctad.org/html/index.html) (<http://globstat.unctad.org/html/index.html>)

UNCTAD also offers country fact sheets that provide foreign direct investment figures and offer specialized types of information, such as [Largest Transnational Corporations](http://www.unctad.org/Templates/Page.asp?intltemID=2443&lang=1) (<http://www.unctad.org/Templates/Page.asp?intltemID=2443&lang=1>)

Researchers may navigate to the WTO's [Statistics Database](http://stat.wto.org/Home/WSDBHome.aspx?Language=) (<http://stat.wto.org/Home/WSDBHome.aspx?Language=>) which offers trade profiles and tariff profiles for countries; or they may go to WTO's [International Trade Statistics 2007](http://www.wto.org/english/res_e/statis_e/its2007_e/its07_toc_e.htm). ([http://www.wto.org/english/res\\_e/statis\\_e/its2007\\_e/its07\\_toc\\_e.htm](http://www.wto.org/english/res_e/statis_e/its2007_e/its07_toc_e.htm))

At this site, one may browse by country members, and quickly access pages that contain, among other more lengthy reports and publications, OECD statistical profiles

Another valuable resource is [International Trade Statistics](http://www.intracen.org/tradstat/) (<http://www.intracen.org/tradstat/>), which in its current version includes 2001-5 import/export data under "General Trade Data 2001-2005." This is an interactive database with statistics retrievable by either country or product groups

[UN Comtrade](http://comtrade.un.org/) (<http://comtrade.un.org/>) offers another valuable series of statistical databases.

The IMF site offers hyperlinked macroeconomic statistics and projections from its premier publication, [World Economic Outlook](http://www.imf.org/external/pubs/ft/weo/2008/01/index.htm) (<http://www.imf.org/external/pubs/ft/weo/2008/01/index.htm>) links directly to countries' central banks, in many cases; and offers access, via the Country Information page, to the full text of in-depth IMF country reports, which go back to the 1990s.

By navigating to the “Data and Research” page from the [World Bank's](http://www.worldbank.org/) (<http://www.worldbank.org/>) home page, and then using the "Data" tab (<http://econ.worldbank.org/WBSITE/EXTERNAL/EXTDEC/0,,menuPK:476823~pageP>

Country information targeting the Americas is available from the regional Pan American Health Organization. (<http://www.paho.org/english/country.htm>)

[Doing Business](http://www.doingbusiness.org) (<http://www.doingbusiness.org>) is a joint venture between the World Bank and its private arm the International Finance Corporation. [Doing Business](http://www.doingbusiness.org) can be used to easily generate reports about economies and country comparisons, as well as accessing laws of countries. In addition, individuals may access Economy Rankings from the home page, which offers an "Ease of Doing Business Rank" for 175 countries.

[Enterprise Surveys](http://enterprisesurveys.org) (<http://enterprisesurveys.org>) provides insights into investment climates based on the survey responses of more than 66,000 firms worldwide. [FDI.net](http://www.miga.org), from the [Multilateral Investment Guarantee Agency](http://www.miga.org) (<http://www.miga.org>) of the World Bank, offers foreign direct investment financial information, and related information for relevant countries of the world to aid business professionals in making key decisions concerning investment abroad.

Many international organizations have partnered to collaborate on statistics that likely could not be obtained independently. An interesting collaboration is the [Joint External Debt Hub \(JEDH\)](http://www.jedh.org/) (<http://www.jedh.org/>) giving estimates of national debt and related statistics and information.

JEDH is a joint project of the IMF, OECD, Bank for International Settlements, and World Bank. Like the IMF and OECD, the BIS enables international monetary cooperation by serving as a bank for central banks worldwide.

From its [Central Bank Websites](http://www.bis.org/cbanks.htm) page (<http://www.bis.org/cbanks.htm>), the BIS links to the sites of countries' central banks, which often list key country interest rates that may be used as indicators in country risk analyses.

Another trend among organizations is collaborating with or gleaning information from governments and commercial firms to achieve goals. For instance, country information in FDI.net is partially from government sources, but also comes from country intelligence firms like the [Oxford Business Group](http://www.oxfordbusinessgroup.com/) (<http://www.oxfordbusinessgroup.com/>)

## UNITED NATIONS

The United Nations was formed in 1945, an international organization founded to promote peace and avoid international conflicts. The UN fosters international cooperation in many areas besides peace and security, including human rights and economic, social, trade, and political development; in turn the UN has become an authoritative powerhouse for all types of country information.

For instance, the [United Nations Statistics Division's Statistical Databases](http://unstats.un.org/unsd/databases.htm) (<http://unstats.un.org/unsd/databases.htm>) provides users with streamlined access to two fee-based subscription databases, and thirteen unrestricted databases, on a variety of wide-ranging topics. Yet there appears to be no centralized Web site or portal that provides streamlined, comprehensive access to all the best UN country-level information.

Many UN agencies provide topical country profiles for their particular area--important information that should not be overlooked.

For general country information and detailed information about governments and the legislatures, a good starting point is the [United Nations Online Network in Public Administration and Finance: UNPAN](http://www.unpan.org) (<http://www.unpan.org>) and its related [Publication Administration Country Profiles](http://www.unpan.org/dpepa/country%20profiles/countries.asp) site. (<http://www.unpan.org/dpepa/country%20profiles/countries.asp>)

A valuable forecasting tool is [World Population Prospects: The 2006 Revision Population Database](http://esa.un.org/unpp/), which predicts populations to the year 2050.

The UN has Web sites with country information for every major business sector. These include the Food and Agriculture Organization's [FAO Country Profiles and Mapping Information System](http://www.fao.org/countryprofiles/inventory.asp?lang=en)  
(<http://www.fao.org/countryprofiles/inventory.asp?lang=en>)

and the [International Telecommunication Union](http://www.itu.int) (<http://www.itu.int>) along with [UNIDO: United Nations Industrial Development Organization](http://www.unido.org) (<http://www.unido.org>)

The UN has formed several regional commissions for economic development information, but these commissions do not all provide uniform kinds of country-level information.

The United Nations Economic Commission for Europe stands out for offering the useful [UNECE Statistical Database](http://w3.unece.org/pxweb/Dialog/Default.asp) (<http://w3.unece.org/pxweb/Dialog/Default.asp>)

and for publishing an annual compilation of country profiles with many visuals, the current one being [UNECE Countries in Figures 2007](http://www.unece.org/stats/profiles2007/)  
(<http://www.unece.org/stats/profiles2007/>)

The **UNESCO Institute for Statistics** focuses on the "core themes" of education, literacy, science/technology, and culture/communication, and would be a good resource for finding specialized reports about the state of the world's libraries.

The UN produces many resources that document its development efforts.

The [United Nations Development Programme](http://www.undp.org/) (<http://www.undp.org/>) offers news and general information. Other resources are the UNDP's Human Development Reports, available from the UNDP home page and Statistics of the Human Development Report, accessible from the Human Development Reports page; these include the highly publicized Human Development Index (HDI) rankings.

**A Think Tank or Policy Institute conducts analyses, and advocates for causes and policy changes by influencing and offering advice to governments and top decision makers.**

A number of organizations synthesize or reformat information to aid understanding and comparability, and tend to focus on specific topics that may be challenging to locate by other means.

By shedding light on irresponsible governments, policy makers, and corporations, all of these entities hope to pressure them to make more responsible decisions and end abuses.

Michigan State University assembles quality Internet resources.

Examples are the multidisciplinary country studies portal [MSU Global Access](http://www.msuglobalaccess.net/) (<http://www.msuglobalaccess.net/>) and the international business portal [globalEDGE](http://globaledge.msu.edu/) (<http://globaledge.msu.edu/>) from its Center for International Business Education and Research.

An excellent resource, *globalEDGE* offers more than 5,000 annotated Internet resources (including other academic Web sites) that assist with identifying international statistics. *GlobalEdge* also highlights recommended resources and offers usability and content ratings. Value-added informational tools created by the GlobalEdge team include Country Insights, available from the home page, and the annual Market Potential Indicators for Emerging Markets, available under "Resource Desk."

Country Insights identifies major producers of information within countries, such as the central statistical agencies, and provides one-page executive memos that were done in collaboration with Export.gov.

The Market Potential Indicators for Emerging Markets 2007 is an overall ranking based on The Economist's categorization of twenty-seven countries as emerging markets. Other resources available from *GlobalEdge* are industry profiles, news, diagnostic tools, and professional networking.

The GTN country summaries address key issues impacting countries' overall trading environment and economic outlooks, presented using a succinct narrative approach rather than a quantitative one. GEM evaluates entrepreneurial climates of major countries of the world.
